Tips For Good Audition Entries

Below are some general tips to help both the director or private teacher with submitting any entry forms.

- Check and double check your division (vocal, band, string, etc) procedures/ eligibilty.
- Meet your deadlines!
- Consider sending your applications by certified mail (not required) to insure delivery. This is an extra expense but worth the peace of mind.
- Make sure your paperwork is complete! Incomplete submissions may delay the process, or your entry form could be nullified.

Can our band legally sell videotaped copies of its concerts?

A single copy of a videotaped performance of your ensemble can be made to keep on file for reference or review. If you want to make multiple copies and distribute them, either with or without charge, you will need permission of the copyright owners for each piece of music performed on the videotape. You will also need permission from parents to have their children videotaped.

Is a public school district allowed to use recorded music of one of their school ensembles in a publication? The publication may be a TV advertisement

Our All State Band conductor, David Albert, and John Hendricks, current WV Adjudicator, will be serving as guest clinicians. All participants will also be adjudicating the performing group privately.

Once the group has performed, our guest clinicians will offer feedback to the group for their benefit and also so the clinic attendees can compare their comments and ratings with those of the adjudicators.

Any band director who is interested in having their group considered to serve as the lab band should respond to tfilben@k12.wv.us by November 1. In the event of multiple entries, a group will be selected at random. All large concert percussion instruments and stands will be provided and the clinic will take place in the all state band rehearsal space on Friday morning. All travel arrangements and expenses are the responsibility of the selected group.

The school must license the music properly with a synchronization license and a mechanical license. Mechanical licenses are available from the Harry Fox Agency. For synchronization licenses, contact the publisher directly (publisher information is available on the ASCAP, BMI, and SESAC sites). If another business is used, make sure that business is responsible for all licensing. Also, be sure to check local law regulations.

Jason teaches General Music, Strings, Band, and Choir at Simpson Elementary, as well as Band at Johnson Elementary in Harrison County. He holds a B.A. in Music Education, as well as a M.Ed in Online Learning from Fairmont State University. Jason is currently pursuing an Ed.D in Curriculum & Instruction from West Virginia University where his major research emphases are curriculum evaluation of music courses in online K-12 schools. He especially concentrates on their alignment with the National Standards for Music Education, and he is developing a curriculum incorporating Middle Eastern Music in the General Music classroom.
